### **Proposed 2024 Fees**

## **Registration Fees**

Fees have not been increased for many years. Postage increases mean that the clubs are now struggling to break even. Our fees are much lower than other UK registries and FIFe members.

The EC have discussed the current situation and agreed that price increases should be applied on all registrations – *see Appendix* (Club Registration Price List – Proposed Fee Increases) revisions to pricing in red.

As part of these changes we have proposed that all fees should be spilt evenly 50/50 between Felis Britannica (FB) and the clubs, so that they are now making a loss on any registrations.

The EC also propose that a yearly 10% increase in registration fees will then be implemented, which will not need to come back to the AGA each year.

As the clubs are feeling the impact of postage costs now the EC hope these fee increases will be accepted and ask that the clubs agree to these changes coming into effect from 1<sup>st</sup> March 2024.

## **Membership Fees**

FIFe have increased fees for membership to 500 (£435) Euros annually – this is a 150 Euro increase.

FB's historical fee structure is £100 and then £2 for every member above 100. For context this fee structure was adopted from Sverak when our Statutes were drawn up, as Sverak's statutes were used as a basis for our Statutes.

The EC consider it would be fairer to split the fees evenly between the clubs.

The EC therefore recommend the clubs each pay a £150 annual membership fee.

This requires a change to Article 6.10 of the statutes, which has been submitted as a Proposal to the AGM by the EC. This recommendation by the EC is dependent on that proposal being passed by the clubs prior to discussing fees.
